# WINTER PESTS by Tom Ineichen, SPCB Field Specialist

When it comes to "winter pests" in California, I think most people believe that all pests leave for vacation or go dormant as the weather drives them away. But that probably depends a lot more on where you live in California, for we are as diverse in our geography and weather conditions as we are in our housing and pest exposures. So, whether you live in the far north region or mountain ranges with a full snow load, or at the southern border or beaches with more mild winter temperatures, your expectations of what pests will be trying to snuggle up with you may vary. However, Mother Nature and a pest's instinct to survive will be the true test of what pests we're faced with in winter months.

So, what can we really expect? As many can attest, ants and rodents are tupically the most common pests to infest our homes in winter months, starting in the fall season. Whether it's noises in your attic, or the kitchen counter covered with a black crawling mass, many experience the company of these invaders as they seek warmth and shelter from the elements. Some pests such as indoor cockroaches, moths, food (pantry) pests, and bedbugs are unaffected by the change in outdoor weather but may appear to get worse. This is mostly due to the change in our living habits as we raise the temperature in the homes and become more home bound. These pests get more comfortable with humans, their habitat conditions, and will increase in population and sightings. Some pests such as spiders, certain ant species, outdoor cockroaches, earwigs, and flying insects will decrease as theu overwinter or appear in a bit of a dormant season. Although some pests can be driven inside from the elements for food and shelter, and if they find a comfortable and suitable habitat inside, can continue a regular presence

of infestation. So, the fall season may drive them inside, but the winter cold in some regions will affect levels of activity, especially pest like fleas, ticks, earwigs, and flies or gnats. If you have any of these pests inside during winter months, it would be unusual and worthy of calling in the professionals for help to find the source of infestation. Please always check for licensing!

Whether you're one who likes to prepare in advance or just like to wait for the potential that may never happen, here are a couple of tips to help protect the castle and the family from these notoriously relentless intruders. Remember, an ounce of prevention is worth a pound of cure, or—in this case—a lot of hassle and money in dealing with unwanted housequests:

### TIPS FOR WINTER PEST PREVENTION

- Inspect eaves, rooflines, roof vents, foundations, and around doors and windows for areas of possible entry.
- Trim back trees and shrubs to bar rodents from easy access to roofs, subareas, or external entries like vents.
- Repair or replace any areas of rotted wood or large gaps allowing rodents or animals entry.
- **Declutter** basements, attics, garages, and utility rooms to eliminate any potential nesting spots.
- Repair loose mortar and replace worn weatherstripping around all windows and doors.
- Store food in sealed containers and keep crumbs/food off the floor/ground and remove from yard or around trees.
- Seal or caulk all cracks or gaps on the home exterior, including around doors and windows, even small cracks.
- Store firewood at least 20 feet from the home and off the ground and covered or enclosed if possible.
- Clean up loose leaves or piles close to the home and remove all clutter or possible harborage areas.
- Remove all water sources or pooling around the home and keep the home free of water intrusion.
- Keep gutters covered with screen/guards and cleaned and free from leaks and clogging.

California offers several distinct licensina types; each are tailored to serve a specific purpose and uphold the highest standards of competence. These licenses are essential in ensuring the well-being of the industry and the protection of consumers. It is necessary to understand what each type allows its holders to do, as well as the limitations and responsibilities associated with them. Whether you are a licensed practitioner, a business owner, or a concerned consumer, this comprehensive overview will provide you with a clear understanding of the roles and responsibilities associated with each licensing type.



For our exams to be considered a valid exam, they require participation from licensees in the industry in the examination development process. Examination development is conducted in a group setting with licensees known as Subject Matter Experts (SME). SME participation is a critical part in the development of each exam. These workshops play a crucial role in maintaining the highest standards of competency and expertise in the pest control industry throughout California. We are committed to continuously improving and ensuring relevancy of each exam

SME input establishes the minimally acceptable knowledge, skills, and abilities necessary to perform tasks on the job safely and competently. One of the unique features of our workshops is the diverse group of participants they bring together. Licensees from all corners of California converge, creating a dynamic and enriching learning environment. This geographical diversity ensures that examination content is developed with a comprehensive understanding of the challenges faced by pest control professionals statewide. By collaborating with peers from different regions, participants gain insights into best practices and emerging trends that may be region-specific, further enhancing their expertise.



During an exam, examinees can leave comments if they have any questions or concerns about a test question. Comments are reviewed for validity.

## **WOOD DESTROYING ORGANISMS**

Wood Destroying Organisms (WDO) are pest or fungi that impact the structural integrity of wood through their normal life cycles. These include carpenter ants, termites, wood-boring beetles, other pests, and also include wood destroying fungus (dry rot). All WDOs can lead to significant structural damage and costly treatments and repairs.

Most lending institutions require homes in California be inspected for WDOs before financing a home loan. In California, all WDO inspections must be performed by a licensed Field Representative or Operator employed by a pest control company registered in Branch 3 and in good standing with SPCB. All California inspection reports must be completed on the **Wood Destroying** Organism Report Form (43m-41) and filed electronically through the **WDO System** within 10 business days.

#### **NEED A COPY OF AN INSPECTION REPORT?**

SPCB requires all companies that perform WDO inspections to report the address of every property inspected or upon which work was performed. SPCB maintains a database containing the date and address of each report. Anyone can request copies of a WDO report on any property in California.

If you're looking for information about whether a WDO inspection report is on record for a specific property in California, you can utilize the **Property Address Search tool** to review SPCB's records. This search will help you determine if a WDO inspection has been conducted within the past two years at the property in question.

If a WDO inspection report has been conducted for the property you are inquiring about, you may submit a Request for Copies of Inspection or **Completion Report Form**. SPCB staff will retrieve the report from the company and provide it to you at no cost.

If you are considering having a WDO inspection performed on your property, you can check the status of the company that you're considering hiring by using the California Department of Consumer Affair's **License Search** or contact the SPCB Enforcement Unit at pestboardenforcement@dca.ca.gov, or by calling (916) 561-8708.

# STRUCTURAL PEST CONTROL BOARD REGULATIONS—PENDING by Healther Jackson, Regulation and Legislation Specialist

### PESTICIDE APPLICATION NOTICE

### (Amend title 16 CCR 1970.4 and add 16 CCR 1970.41, 1970.42 and 1970.43)

This regulatory proposal encompasses several key changes to existing regulations, First, it introduces a revised Occupants Fumigation Notice and Pesticide Disclosure Form (OFN) through incorporation by reference. The OFN has been revised to align with the language specified in BPC section 8538(a)(1-3) and reformatted to enhance its ease of use and understanding. Additionally, the proposal addresses instances of unclear terminology, making necessary modifications and incorporating various non-substantive edits. It also reorganizes existing requirements by relocating them from subsections b-f into standalone sections, eliminating the need for these subsections.

This regulatory proposal also introduces new or revised requirements, such as mandating the reporting of deaths or serious injuries to the County Agricultural Commissioner in the county where the pesticide application occurred, in addition to the Structural Pest Control Board. It permits electronic notification of post-application pesticide notices for applications related to exterior structures or the interior of commercial, industrial, or single-unit residential buildings, while maintaining existing requirements for multi-unit structures. Lastly, it adds the date of service as a required field on post-application pesticide notices. These changes aim to enhance regulatory clarity and the overall effectiveness of pesticide-related communication and reporting.

### **Public Participation in the Rulemaking Process**

The public may participate in the rulemaking/regulatory process by submitting written comments to SPCB at any regulatory hearing on a rulemaking proposal. When SPCB proposes to adopt, amend, or repeal one of its regulations (title 16, California Code of Regulations, Division 3, commencing with section 8500), the public is provided an opportunity to submit written comments during the noticed public comment period. 

# STRUCTURAL PEST CONTROL BOARD LEGISLATION

### **2023 SUMMARY OF LEGISLATION I** EFFECTIVE JANUARY 1, 2024

Senate Bill 813 (Roth—Chapter 507, Statutes of 2023

**Structural Pest Control Board** 

(Amends sections 8520 and 8528 of the Business and Professions Code)

This bill extends the operation of the board and the authority to appoint an executive officer to January 1, 2028.

Assembly Bill 307 (Chen)—Chapter 82, Statutes of 2023

Structural Fumigation Enforcement Program

(Amends section 8698.6 of the Business and Professions Code)

This bill extends the sunset on the Structural Fumigation Enforcement Program from January 1, 2024, to January 1, 2029.

# ENFORCEMENT UNIT'S ROLE FOR CONSUMERS AND LICENSEES

In 1935, Assembly Bill 2382 created "[a]n act to regulate the practice of structural pest control; to create the Structural Pest Control Board; to provide for the registration and licensing of persons engaged in such practice, and for the protection of the public in the practice of structural pest control."

The Enforcement Unit is staffed with Consumer Service Representatives (CSR) based at SPCB headquarters. Their primary responsibilities involve fielding questions from consumers and licensees and making recommendations for filing formal complaints if warranted. Complaints may be filed by consumers, licensees, and other state agencies. All complaints are reviewed in office and if it is found that the complaint does not fall in SPCB's jurisdiction, the complaint will be referred to the proper agency.

CSRs are tasked with providing initial support during the beginning stages of the complaint process, gathering relevant information from both parties, and attempting to mediate resolution on the issues raised in the complaint. In cases where mediation is unsuccessful, the CSR may escalate the matter to an SPCB Specialist. The Specialist is responsible for determining if any violation of the SPCB Act has occurred. If a violation has been determined, the Specialist will work with the registered company/licensee to bring the property or structure into compliance or otherwise correct the violation.



#### THE ENFORCEMENT UNIT'S ROLE:

- Answers questions and concerns from both licensees and consumers.
- Assists complainants and licensees in determining the best course of action towards resolution.
- Refers matters outside of the SPCB's jurisdiction to the proper agency.

#### **HOW TO FILE A COMPLAINT?**

#### SPCB INVESTIGATES COMPLAINTS INVOLVING:

- Unlicensed activity within the state.
- Licensee failure to complete a contract.
- Repairs not performed in accordance with trade standards.
- Infections or infestations missed or not reported on an inspection report.

#### **ACTIONS BEYOND THE SCOPE OF THE ENFORCEMENT UNIT:**

- Mediation between a landlord and tenant
- Mediation between homeowners and a Home Owners Association.
- Process a complaint after the two years statute of limitations unless the case involves fraud or misrepresentation which allows up to four years.

The complaint form and any important information and documents regarding the complaint can be emailed to the Enforcement Unit at pestboardenforcement@dca.ca.gov.

This form and supplemental documentation can also be mailed to SPCB at 2005 Evergreen St., Suite 1500, Sacramento, CA 95815.

Once the complaint and all supplemental documentation is received, the Enforcement Unit will begin their investigation.

	GLOSSARY OF TERMS
Accusations	Charges filed against a licensee or company registration alleging violation(s) of the Structural Pest Control Act.
Interim Suspension Order	An Order issued upon petition suspending a licensee or company registration from all or part of their practice of the provisions of the Structural Pest Control Act.
Petition to Revoke Probation	Charges filed against a probationer seeking revocation of their structural pest control license or company registration based upon violation(s) of probation.
Probationary License	When good cause exists to deny a license or company registration, SPCB has the option to issue a conditional license or company registration subject to probationary terms and conditions.
Statement of Issues Filed	Is filed to deny an application of an applicant for the commission of acts, which if committed by a licensee would be cause for license discipline.
Surrender of License	The licensee surrenders their license or company registration to SPCB, subject to acceptance of the surrendered license or company registration by SPCB. The licensee is prohibited from engaging in the practice of structural pest control.
Stipulated Decision	Negotiated settlements waiving an Administrative Hearing.
